ABOUT THE POSITION:

The Managing Director, Sites will be responsible for supporting and overseeing GreenLight's work in the cities/regions in which it operates. Managing and mentoring the organization's Executive Directors, the Managing Director will work to ensure best-in-class program delivery. Reporting into the Chief Executive Officer, the Managing Director will manage a team of seven Executive Directors and support the senior leaders and Board as a key member of the national Management Team.

This is an ideal opportunity for a seasoned coach and manager with exceptional strategic thinking skills to play a critical leadership role within a growing organization poised to make significant impact nationally.

Responsibilities include, but are not limited to:

Organizational Leadership

- In partnership with the CEO and other leadership, set GreenLight's vision and direction, supporting site Executive Directors in meeting and exceeding goals
- Establish an effective cadence for site management, balancing fidelity to GreenLight's model and values with appropriate autonomy in each site
- Develop a clear, mission-aligned vision for how site and national leaders and teams will operate together, with an eye towards collaboration, innovation, local impact and efficiency
- Build systems, policies and dashboards to ensure GreenLight's operational structure supports growth while maintaining exceptional quality and program consistency
- Leverage qualitative and quantitative data in decision-making, structure decision-making to support participation from multiple stakeholders from national and local teams
- Support storytelling and communications for the organization as a whole, lifting up stories that are locally relevant while communicating with a nationally consistent voice and message
- Advocate for local sites' needs and perspectives internally with the national Management Team



Team Management

- Manage and support each Executive Director towards achieving their site-specific goals and growth targets
- Build a culture that embraces diversity, equity and inclusion, modelling inclusive leadership and working effectively with staff from a range of cities and a diverse set of life experiences
- Coach Executive Directors and provide ongoing professional development, mentorship, and thought-partnership
- Support Executive Directors on meeting and exceeding both program and fundraising goals, enabling them to manage their local teams and stakeholders
- Ensure each Executive Director has the staff capacity and infrastructure needed to maximize impact and achieve their goals
- Establish key performance indicators to measure operational effectiveness; track performance against those indicators, providing feedback and guidance and refining indicators as necessary

CANDIDATE REQUIREMENTS:

The ideal candidate will possess the following qualifications:

- 5+ years of management experience in a geographically dispersed, multi-site organization, with demonstrated success managing individuals and teams to goals
- Excellent leadership skills including the ability to inspire, motivate, influence, and hold both local and remote staff accountable to significant standards and goals
- Ability to lead others through a time of significant growth/change, anticipating challenges and adjusting course as needed
- Exceptional critical thinking skills evidenced by a track record of anticipating and identifying problems, weighing options and providing recommendations that yield positive outcomes
- Collaborative approach to executive leadership, and the ability to work effectively within a multi-site organization to meet goals and improve organizational performance
- Familiarity with fundraising in a dynamic, entrepreneurial environment, particularly with major donors; ability to coach and mentor others on fundraising best practices and approaches
- High degree of integrity, models and encourages ethical behavior and decision making at all times
- Commitment to diversity, equity and inclusion, with ability to serve as an exemplar for GreenLight's values and foster an inclusive and respectful workplace
- Track record of establishing buy-in across stakeholders and influencing diverse groups of individuals and networks to achieve results
